## Corrigendum to “Random walks and diffusion on networks” [Phys. Rep. 716–717 (2017) 1–58]

In Eq. (8), the first factor should be  $1/(4\pi Dn)^{1/2}$ , rather than  $1/(2\pi Dn)^{1/2}$ . The correct equation is

$$p(x; n) = \frac{1}{(4\pi Dn)^{1/2}} e^{-\frac{(x-n)^2}{4Dn}}. \quad (1)$$

In Eq. (33), the sum in the denominator of the first fraction should be over the neighbors of node  $i$ . In other words, it should be the same as the sum in the second fraction on the right of Eq. (33). The correct equation is

$$T_{ij} = \frac{(s_i s_j)^\alpha}{\sum_{\ell: v_\ell \in \mathcal{N}_i} (s_i s_\ell)^\alpha} = \frac{s_j^\alpha}{\sum_{\ell: v_\ell \in \mathcal{N}_i} s_\ell^\alpha}. \quad (2)$$
